**RESERVATIONS, DEPOSIT, AND PAYMENT:** The Belize Mission Trip price, includes all lodging, almost all food, transportation (while in Belize), and personal insurance from February 18-March 3, 2020. **Space is limited.** To make your reservation (deadline: December 12, 2019), please call Maria Rayburn at (423) 362-5846 or send an e-mail to [mariar@iiw.org](mailto:mariar@iiw.org). Reservations are accepted and confirmed after we receive a non-refundable deposit of \$500, the Registration form and the Release of Liability and Assumption of All Risks form. The remaining must be received by January 14, 2020.

**EXCLUSIONS:** Expenses and terms not mentioned are not covered, including but not limited to: passport, immunization charges, airfare to and from Belize, snacks, soft drinks, bottled water, laundry and pressing services, items of a personal nature, and baggage handling. The purchase of this Belize Mission Trip is not tax deductible and cannot be applied toward any It Is Written Partnership commitments.

**HEALTH REQUIREMENTS:** In order to enjoy the Belize Mission Trip, participants must be in general good health. The trip is intended for persons of reasonably good health and without serious physical disabilities.
