RESERVATIONS, DEPOSIT AND PAYMENT: The Costa Rica Mission Trip price, \$1250, includes all lodging, <u>almost</u> all food, transportation (while in Costa Rica), and personal insurance from June 2-14, 2020.

Space is limited. To make your reservation (deadline: March 5, 2020), please call Maria Rayburn at (423)362-5846 or send an e-mail to <u>mariar@iiw.org</u>. Reservations are accepted and confirmed after we receive a non-refundable deposit of \$500, the Registration form and the Release of Liability and Assumption of All Risks form. The remaining \$750 must be received by April 9, 2020.

EXCLUSIONS: Expenses and terms not mentioned are not covered, including but not limited to: passport, immunization charges, airfare to and from Costa Rica, snacks, soft drinks, bottled water, laundry and pressing services, items of a personal nature, and baggage handling. The purchase of this Costa Rica Mission Trip is not tax deductible and cannot be applied toward any It Is Written Partnership commitments.

HEALTH REQUIREMENTS: In order to enjoy the Costa Rica Mission Trip, participants must be in general good health. The trip is intended for persons of reasonably good health and without serious physical disabilities. Therefore, it is imperative that persons with medical problems make them known at the time of registration. It Is Written reserves the right to decline to accept anyone as a Costa Rica Mission Trip participant if they are deemed to be medically unfit for travel. By submitting a deposit for the trip, you certify that you do not have any physical disability that might create a hazard for yourself or other participants. It Is Written assumes no liability regarding the provision of medical care or any special medical accommodations. It is the responsibility of the participant to check with their medical professionals to ensure that they are fit for the journey.
